Selectman Blake Motions to release the claim. Selectman Nadeau Seconds. Motion Passes 5-0.

**d. Committee for Fire Chief Search:** Chief presented selections for the Committee: Keith Russell and Kenny Scribner. Chief would be on Committee too. Selectman George and Selectman Beaulieu will also be on the Committee. Chief reaching out to Greg Payson, Chief at North Yarmouth, to be on the Committee as well. Discussed that one of the Selectman should Chair the Committee. Ruth will get together binders of Applicants for all members to have.

## Selectman Nadeau Motions to start the process for Contract Planner Services RFP. Selectman Blake Seconds. Motion Passes 5-0.

**f. Capital Improvement Plan next steps.** Discussed coming up with a longer-range vision for all. Want to create a policy to bring to Town Meeting in April. Selectman Pontau is going to create a template for all.

**g. Planning Board Vacancies**: Ruth presented that Chair of the Planning Board, Mindy Woerter, has resigned. Vice Chair, Anne Torregrossa will sit as Interim Chair. Leaves four members on the Planning Board. Need to advertise out for new members, need one (1) regular member, and two (2) alternates. Tammy will advertise through website and social media.

## **Departments/Committees:**

**a. Road Commissioner** – Not Present. Selectman Nadeau asked Ruth to have Calvin come up with a priority list/2-5 year plan of road maintenance, repairs and rebuilds with cost estimates for the bond for next time he presents to the Board

## **b. Town Administrator**:

- Ruth presented Oaths for Bob Forrest – E911 and Licensed Plumbing Inspector.

Selectman Pontau Moves that Robert Forrest be appointed to the Oath of Office for E911 and Licensed Plumbing Inspector. Selectman Blake Seconds. Motion Passes 5-0.

- 3 new foreclosures have been done: 2 land, and one property
- Discussed Staff evaluations, what they Board will do, and what the Supervisors do. Board will be doing Calvin and Ruth's Evals.
- Office Restorations. Ruth presented about getting new chairs for meeting room.

## Selectman Blake Moves to purchase no new chairs. No Seconds. Motion Fails. Selectman Pontau Moves to purchase chairs in meeting room to replace the cloth chairs, but to keep the plastic ones. Selectman Beaulieau Seconds. Motion Passes 4-1.
