b) Rocco and Rebekah Abbatemarco: Conditional Use Permit for an accessory apartment: The Board finds the application complete.

Chairwoman Torregrossa Moves to issue a Conditional Use Permit for an accessory apartment. Board member Cobb Seconds. Motion Carries 7-0.

c) CEO Bob Forrest: Request for Temporary Activity Permit for a resident to sell Christmas trees: The Board discusses whether a permit is needed and conclude that a permit isn't needed because it is an agricultural use, which is allowed in this zone.

Chairwoman Torregrossa Moves to declare that a Temporary Activity Permit is not necessary for the sale of Christmas trees in this zone. Board member Cobb Seconds. Motion Carries 7-0.
