# 4. Public Input Regarding Use of ARPA Funds

Email from Jim Sanborn:

#### 5. Large Format Scanner Proposal/Discussion (Alan Plummer – Codes Officer)

Proposal for cash option - \$7,120, plus \$395 maintenance fee

Josh Klein-Golden motions that the Board authorize expenditure of up to \$7,600 for the purchase of the large format scanner. Joe Tomm seconds. Motion carries 4-0.

#### Road Commissioner

- Working on the trucks, preparing them for the winter season
- Staffing for Public Works looks great CJ Larrabee is returning this season to the team
- Finished grading all the gravel roads
- Roger Griswold (weather meteorologist from WMTW) gave a class on weather forecasting difference between dew points vs. relative humidity (helping to determine black ice conditions)

- MaineDOT installed the guard rails on Route 9 near the culvert washout
- MaineDOT installed the warning lights near Route 9 and Swamp Road
- Crooker is finishing up paving on Bowie Hill Road should be complete by Monday, November 28<sup>th</sup>.
- Continuing to work on the 2023 Public Works Budget
- New Plow Truck arrived in Westbrook, waiting for Viking to schedule a time to get equipment on it.

#### Fire Chief

- November 20<sup>th</sup> The entire department went to Yarmouth for a live fire training
- The department received 35 911 calls for the month of October.
- Over 300 calls for service/41 responses
- The Fire Department Safety Committee has now joined the Town's Safety Committee.
- The Fire Chief has established and updated the "return to work" policy
- The Fire Department is still hiring for new EMS Per Diem shifts.
- Budget is on track
