 - Welcome our new Code Enforcement Officer ~ Alan Plummer
 - Ad was placed in local newspapers for the Part-Time Deputy Clerk
 - The Town Offices will continue to accept applications for a Town Manager.
 - Counter Service continues to be busy for the Town Clerk and Deputy Treasurer ~ continue to close the town offices on Wednesdays to get work completed.
 - Deputy Treasurer locked in a one-year contract with Downeast Energy for Propane @2.699per gallon.
 - Energy Issues and Concerns for the Public Works Department Fuel Budget.
 - Projected 2200 gallons of heating fuel budgeted at 3.64 gallons/actual cost *5.33 gallons
 - Projected 12,200 gallons of Diesel budgeted at 2.59 gallons/actual cost *5.56 gallons
 - Projected 1750 gallons of Gasoline budgeted at 2.37 gallons/actual cost *3.92 gallons

(*Actual cost as of May 10, 2022)

- Heating and Cooling system at the Town Office needs to be addressed ~ Board recommends a special town meeting to discuss this issue. (Get proposals for work to be done.)
- Connectivity to the Eureka Center/Broadband speeds~ Board recommends addressing the IT issues at a later date to look at possible use of ARPA funds.
