- I was on Vacation last week but did stay in touch via cell phone.
- Ron Has been out for a couple of weeks now with a medical condition. I will be checking in with him this week to get an update regarding a return date.
- One of our plow drivers has left to go work for a local distributor where he can earn much more money and still be home every night. He said he enjoyed working here but really needed to get out of an apartment and into a house, so money was the deciding factor.
- The weight restriction signs have come but they didn't read "Through Trucks" so I ordered riders to attach so that it is clear that the restriction is for through trucks only and not for local deliveries etc. We will put the signs up once the riders arrive.
- I have continued to work with the MDOT on the Meadow Road and Rt 125 intersection. The pavement they put down was moving and rutting so they are going to put down a 1" lift intermediate layer this week before putting on the surface.
- We have finished ditching on Chickadee, Whippoorwill, Hunter Hill, Ada, and Smith Farm Roads. We are currently ditching on Harley Woods and should be done there by early next week before moving to Puritan.
- We are doing roadside mowing this week and should be done at the end of the week.
