

# Town of Durham Board of Selectmen

## Town Hall March 28, 2023 Meeting Minutes

#### 1. Call to Order & Establishment of Quorum, Pledge of Allegiance

In Attendance: Kevin Nadeau (Chair), Rich George (Vice-Chair), Todd Beaulieu, Joe Tomm, Josh Klein-Golden, Jerry Douglass (Town Manager).

### 4. Freeport Scholarship Foundation

- Board members Kim Wing and Fred Palmer
- Mitchell Scholarship awards a Junior and Senior \$20,000 Scholarship (\$5,000 per year to the college of their choice) and this scholarship includes a mentor to assist and guide the recipient to prepare for their college education.
- University of Southern Maine (USM) Promise Foundation Scholarship awarded to a qualifying student who wishes to attend USM for a 4-Year Program for free.
- FSF has a \$2 Million Dollar Goal, currently the Foundation has \$1 Million Dollars and is seeking Leadership Donors.
- FHS Scholarship offers 4-Year \$20,000 Scholarship (\$5,000 per year) and a Vocational Program Scholarship (\$4,000 per year).
- FHS Scholarship currently has 12 Community Members, seeking a representative from Durham as well as mentors.
- Seeking First Gift of \$30,000

The Chairman of the Board addressed the committee members that the request for the \$30,000 would have to be put on an article for the next Town Meeting in April of 2024 for the townspeople to vote on.

#### 5. Durham Ball Field Discussion

- Review of the Lease Agreement Town Attorney deemed the lease to be not valid due to the resolve of Durham Softball.
- Rich George reached out to Durham Youth Baseball and Tri-Town Little League/Softball and both organizations have worked out a plan that works for both organizations. Tri-Town will use the DCS Softball Field and Durham Youth Baseball will use the Durham Ball Field (Behind Eureka).

Kevin Nadeau moves to authorize the Town Manager to enter a 3-Year Contract with Durham Youth Baseball for the use of the Durham Ball Field (Behind Eureka) and permit DYB to begin scheduling and pre-season work pending the signing of the lease agreement.

Kevin Nadeau amended his motion to authorize the Town Manager to contract up to 5 years with Durham Youth Baseball with negotiated renewal clauses as the parties agree upon and that we allow DYB to proceed with scheduling and pre-season work pending the signing of the lease agreement. Joe Tomm seconds, motion carries 5-0.
